6. To request the deletion, destruction, or anonymization of your personal data in case the reasons for processing them disappear, despite being processed in accordance with the provisions of Law No. 6698 and other related laws, and to request the notification of the transaction made within this scope to the third parties to whom the personal data has been transferred,
7. To object to the occurrence of a result against you by analyzing the processed data exclusively through automated systems,
8. To request compensation for the damage in case of loss due to unlawful processing of personal data.

Our Company will conclude your application as soon as possible and within thirty (30) days at the latest, depending on the nature of your request pursuant to Article 13 of Law No. 6698.

2. Information Request Methods

Pursuant to Article 13 of Law No. 6698 and Article 5 of the Communiqué on the Procedures and Principles of Application to the Data Controller, you can submit your requests to our Company in writing or through registered electronic mail (KEP) address, secure electronic signature, mobile signature, or by using your electronic mail address that you have previously notified to our Company and is registered in our system.
